### Who can use this form?

People with Medicare who want to join a Medicare Advantage Plan. To join a plan, you must:

- Be a United States citizen or be lawfully present in the U.S.
- Live in the plan's service area
- Be a resident in an American Health Advantage of Indiana contracted nursing home facility
- - or live at home and the plan has obtained certification that you need the type of care that is usually provided in a nursing home.

**Important:** To join a Medicare Advantage Plan, you must also have both:

- Medicare Part A (Hospital Insurance)
- Medicare Part B (Medical Insurance)

#### When do I use this form?

You can join a plan:

- Between October 15-December 7 each year (for coverage starting January 1)
- Within 3 months of first getting Medicare
- In certain situations where you're allowed to join or switch plans

### What do I need to complete this form?

- Your Medicare Number (the number on your red, white, and blue Medicare card)

- If you want to join a plan during fall open enrollment (October 15 December 7), the plan must get your completed form by December 7.
